For instance, a "Senior Statesperson" is a lawyer who no longer works hands-on with the same intensity but continues close relationships with major clients and is integral to the firm's success. The "Up-and-Coming" recognition is for attorneys who do not yet have an established reputation but who are driving their firm's growth.
